# **Course Description**

This course examines the role of the federal, state, and local government in the economy. We will examine externalities, public goods, social insurance, and taxation. For each topic, we will discuss the economic theory, a policy application that is informed by the theory, and the empirical evidence related to the theory. This course will investigate the following questions and develop the economic tools appropriate to answer them:

- When should the government intervene in the economy?
- How might the government intervene?
- What is the effect of those interventions on economic outcomes?
- Why do governments choose to intervene in the way that they do?

Prerequisites: ECON 1100 (Principles of Microeconomics) ECON 1200 (Principles of Macroeconomics)

*Exams*: The midterm exam will take place on March 13 in class. The final exam will be scheduled during the semester by the Registrar. The final exam will be cumulative. You will be responsible for all of the assigned chapters even if the material was not specifically mentioned in the class, up until the day of the exam unless otherwise mentioned. You will be permitted to bring one handwritten page of notes on one side of a letter-size sheet of paper to the exam. You are not permitted to consult other students' exams from prior semesters.

*Papers*: Four short papers will be due throughout the semester before the beginning of class on February 18, March 4, April 8, and May 8. These papers will be an analysis of a government policy using the economic tools developed throughout the semester. You are expected to work independently on this assignment and include references to the literature that you consult for this paper. Guidelines for referencing the literature and further details about the assignments will be distributed through ICON. These papers must be submitted electronically using the dropbox on the course page on ICON as either a Word or PDF file, and these papers will be scanned for plagiarism.

*Homework*: You will be given 5 homework assignments throughout the semester to help prepare you for the exams. Assignments will be due at the beginning of class.
